

ANNUAL MEETING OF THE ISANTI COUNTY BOARD OF COMMISSIONERS

Tuesday, January 6th, 2009; 9:15 a.m. - Government Center Boardroom

o0o At 9:15 a.m. the meeting was called to order by County Board Clerk, Jerry Tvedt, leading the assembly with the Pledge of Allegiance. The Board Clerk called for the election of the County Board Chairperson.

09/01-01 Motion by Larson, seconded by Morris to nominate Commissioner Daudt as Chair of the County Board for 2009. Motion carried unanimously.

o0o Kurt Daudt, Board Chair asked for the election of the County Board Vice Chair for 2009.

09/01-02 Motion by Larson, seconded by Southerland to nominate Commissioner Morris as the Vice Chair of the County Board for 2009. Motion carried unanimously.

09/01-03 Motion by Duff, seconded by Morris to approve the agenda with the following addition: to approve the LELS Dispatcher/Jailers Union Contract after the closed session. Motion carried unanimously.

09/01-04 Motion by Morris, seconded by Southerland to approve the minutes of the December 17th, 2008 County Board minutes with corrections. Motion carried unanimously.

09/01-05 Motion by Larson, seconded by Morris to approve the following Health Board Actions: Letter of Understanding with Outlook Clinic for Space; Letter of Understanding with City of Isanti for Hepatitis B Vaccine; 2009 Tobacco Licenses for Dusty Eagle Bar and Grill; Rum River VFW Post 2735; Outback Saloon and Grill; Crown G&G; Captain's on Long Lake; Purple Hawk Supper Club; Riverside Market; Northland 66; T&C Self Serve; and Isanti Municipal Liquor; Medical Consultant Agreement with Allina Health System. Motion carried unanimously.

09/01-06 Motion by Southerland, seconded by Larson to set the 2009 County Board Meeting dates for the 1st and 3rd Wednesdays. Voting Yes: Larson, Southerland. Voting No: Daudt, Morris, Duff. Motion failed.

09/01-07 Motion by Morris, seconded by Duff to set the 2009 County Board Meeting dates for the 1st and 3rd Tuesdays. Voting Yes: Daudt, Morris, Duff. Voting No: Larson, Southerland. Motion passes.

o0o Bill Becklin, Consultant, presented preliminary plans and specs for the restoration of the Spencer Brook School. Becklin noted that the building was previously evaluated and gone through with a letter addressed to the state on what building needs to be done to restore, they put plans together and specs to accomplish this. Coordinator Tvedt indicated to the Board that the Historical Society has received a grant from the State Historical Society in the amount of \$34,000; further the County has approved \$10,000 in 2008 and \$10,000 in 2009 for this project. Commissioner Duff indicated that he would like to see the Board receive construction plans and specs prior to any future board meetings.

09/01-08 Motion by Larson, seconded by Southerland to approve the bid plans and specs for the Spencer Brook School Restoration and to authorize to advertise for bids for said restoration. Motion carried unanimously.

o0o Chad Struss, Assistant Auditor/Accountant presented amendments to the County's Capital Asset Policy and is asking for approval.

09/01-09 Motion by Morris, seconded by Larson to approve the amendments to the County's Capital Asset Policy (on file in the Auditor/Treasurer's Office). Motion carried unanimously.

09/01-10 Motion by Southerland, seconded by Duff to approve the following January 2009 Abatements; Bradley Engblom-PID #06.033.0200, Reason-Clerical Error, Tax Adjustment \$34; Steve Gilbraith-PID #01.007.1000, Reason-Clerical Error, Tax Adjustment \$26. Motion carried unanimously.

o0o Dave Matchinsky, Deputy Sheriff, presented information regarding the Minnesota Internet Crimes Against Children Task Force, with the purpose of implementing a three pronged approach to combat Internet Crimes Against Children: prevention, education and enforcement. Matchinsky indicated that if Isanti County enters into this Multi Agency Law Enforcement Agreement, Isanti County would receive a computer, would receive free training and would get help when needed from other jurisdictions, and there would be no cost to the County.

09/01-11 Motion by Southerland, seconded by Morris to approve the Minnesota Internet Crimes Against Children Task Force Multi Agency Enforcement Agreement. Motion carried unanimously.

09/01-12 Motion by Southerland, seconded by Duff to approve payment to MCIT for annual insurance (Property and Casualty \$240,800; Workers Comp \$180,974). Motion carried unanimously.

09/01-13 Motion by Morris, seconded by Duff to approve the 2008 vacation carry over for Deputy Chris Caulk of approximately 27.48 hours; due to unique circumstances regarding sheriff's department staffing. Motion carried unanimously.

09/01-14 Motion by Larson, seconded by Morris to authorize the maintenance department to approve claims under \$5000 for the remodeling of the County Government Center. Motion carried unanimously.

09/01-15 Motion by Southerland, seconded by Larson to approve an exempt permit to the Princeton Lions Club for a raffle on February 1st, 2009 (alternate date February 15th, 2009) to be held on Green Lake which is located in Wyanett Township, Isanti County, further to waive any waiting period. Motion carried unanimously.

o0o The following bid was presented for the 2009 Miscellaneous Public Defender: Stephen Anderson, \$36,000. Coordinator Tvedt indicated that this bid was \$14,000 over last year's and recommended rejecting the bid and rebidding.

09/01-16 Motion by Southerland, seconded by Duff to reject the bid from Stephen Anderson, Attorney at Law of \$36,000 for the 2009 Miscellaneous Public Defender and rebid. Motion carried. Voting Yes: Larson, Southerland, Daudt, Duff. Abstains: Morris.

09/01-17 Motion by Larson, seconded by Southerland to approve payment to AMC in the amount of \$13,877 for annual dues. Motion carried unanimously.
