


**BYLAWS**  
**OF THE ISANTI COUNTY**


**PARKS AND RECREATION COMMISSION**

**AS AMENDED JANUARY 17<sup>TH</sup>, 2007**

1. The Commission membership shall consist of eleven (11) voting members. They shall be as follows: one (1) member from the Isanti County Board of Commissioners; and two (2) members from each Isanti County Commissioner District as appointed by the County Commissioner of that District.
2. The voting members of the Commission shall elect the following officers: Chairperson, Vice Chairperson, Secretary and Treasurer. The Chairperson, Vice Chairperson, Secretary and Treasurer shall be appointed for a one (1) year term. It shall be understood that the Vice Chairperson will assume the position of Chairperson upon the completion of the term of office for the Chairperson.
3. The Commission shall meet monthly, on the fourth Tuesday of the month. Other meetings will be scheduled as necessary. Location at which the meetings will be held will be determined on a monthly basis.
4. The duties and functions of the parks and recreation commission shall be as follows:
  - a. Serve in an advisory capacity to the county board, county coordinator and parks and recreation director on parks and recreation matters.
  - b. Maintain an interest in and an understanding of the function and operation of the parks and recreation commission and director's duties.
  - c. Endeavor to secure a full understanding of the county's needs and desires for park and recreation facilities.
  - d. Convey to the county board their understanding of the community's sentiment regarding recreation and parks and to submit recommendations on parks and recreation programs and policies to the County Board.
  - e. Review conditions and adequacy of park property.
  - f. Provide hearings to groups or individuals upon request regarding parks and recreation matters.
  - g. Keep informed and consider all financial aspects pertaining to parks and recreation.
  - h. Consider proper names for county park property.
  - i. Propose regulations for control of county park property to the county board.
  - j. Advise and assist architectural engineers on preparation of specific plans prior to their presentation to the county board for formal approval.

- k. Represent the county at community functions.
  - l. Represent the county at meetings with other communities, county or state boards of similar nature where appropriate.
  - m. Perform other duties and functions or conduct studies and investigations as specifically directed or delegated by the county board.
5. In order for the Commission to conduct business, it will be necessary to have a quorum present. A quorum shall consist of six (6) voting members.
  6. Any member having three (3) absences for reasons unknown from the Commission meetings will be replaced.
  7. Ratification and/or amendments to these Bylaws can be made by the Isanti County Board of Commissioners; also the membership of the Parks Commission may recommend amendments to these Bylaws to the Isanti County Board of Commissioners for their consideration with a 60% vote of the membership of the Parks Commission.
